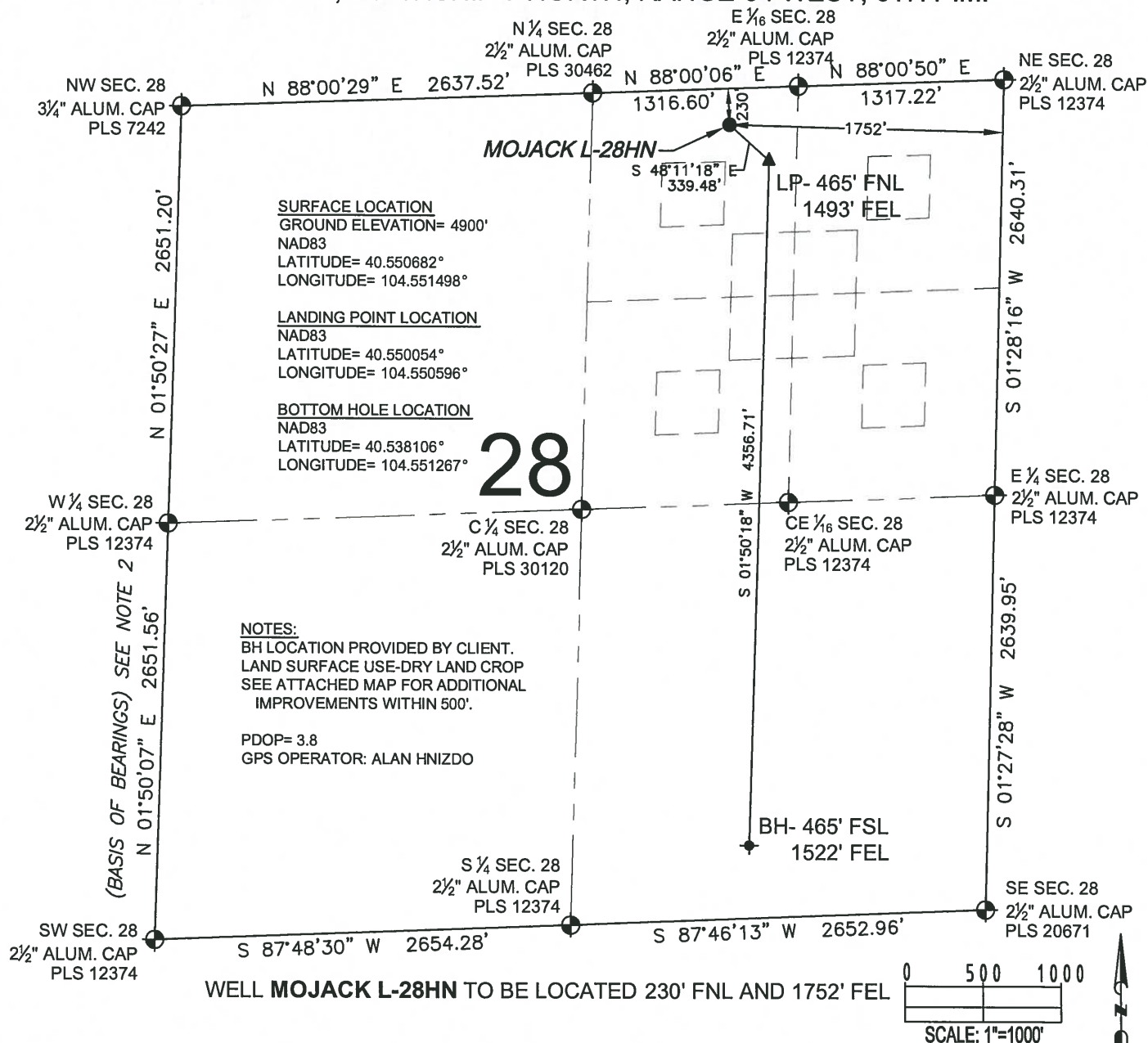


# WELL LOCATION CERTIFICATE: MOJACK L-28HN

## LEGEND

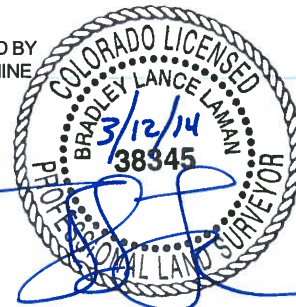
- = EXISTING MONUMENT    ▲ = LANDING POINT
