The surface locations of Bayswater's proposed wells have been staked outside of the COGCC Rule 318A.a. Greater Wattenberg Area (GWA) Drilling Window and are being permitted as exception locations. In addition, under the COGCC Rule 318A.c. any new Twinning well is to be located within 50 feet of an existing well. Bayswater's proposed wells are located approximately 517 feet from the nearest Oil and Gas well. Bayswater has obtained written permission from the surface owner by way of signed waivers.
