PDC moved to the WR 32-10 to perform a MIT, when started pumping fluid to control the well, received communication up the surface immediately and then up around the outside of the surface also. Set a Retrievable Bridge Plug and then ran a packer to isolate the production casing leak. Found 1 hole between 1,735'-1,766'. PDC plans to pull the RBP and set a CIBP at 6450' which is 40' above the top perforation with 2 sacks cement on top. PDC engineering currently evaluating plans to repair or plug the well. ng to pull the RBP and set a CIBP w/ 2 sacks cement on top.
