Operator Comments:

On May 12, 2014, Samson was bringing dirt in to ensure solid compaction upon a known former water based mud pit location in order to house mud tanks for the pending drill rig. This intent was to avoid any new disturbance on the pad to accommodate the rig layout and it was believed that the pit was dry, compact and had plenty of freeboard from the original closure. There was no intent to disturb or excavate the pit or house any other equipment on the pit location post-drilling. As the truck drove over the area, it began to sink, prompting a question if there was soggy soil below. An initial excavation of the center of the pit ensued to assess the situation which exposed soggy soils with coal fines. Samson immediately stopped the assessment and begin informing all potentially interested parties including BLM, private surface landowner, and the SUIT and began formulating a plan. Upon discussions with all interested parties, a soil sampling was set up for May 16, 2014.

Results of the two (2) sampling are attached. Thirty-five (35) loads were approved and disposed at the Bondad Landfill between May 27, 2014 - May 29, 2014.
