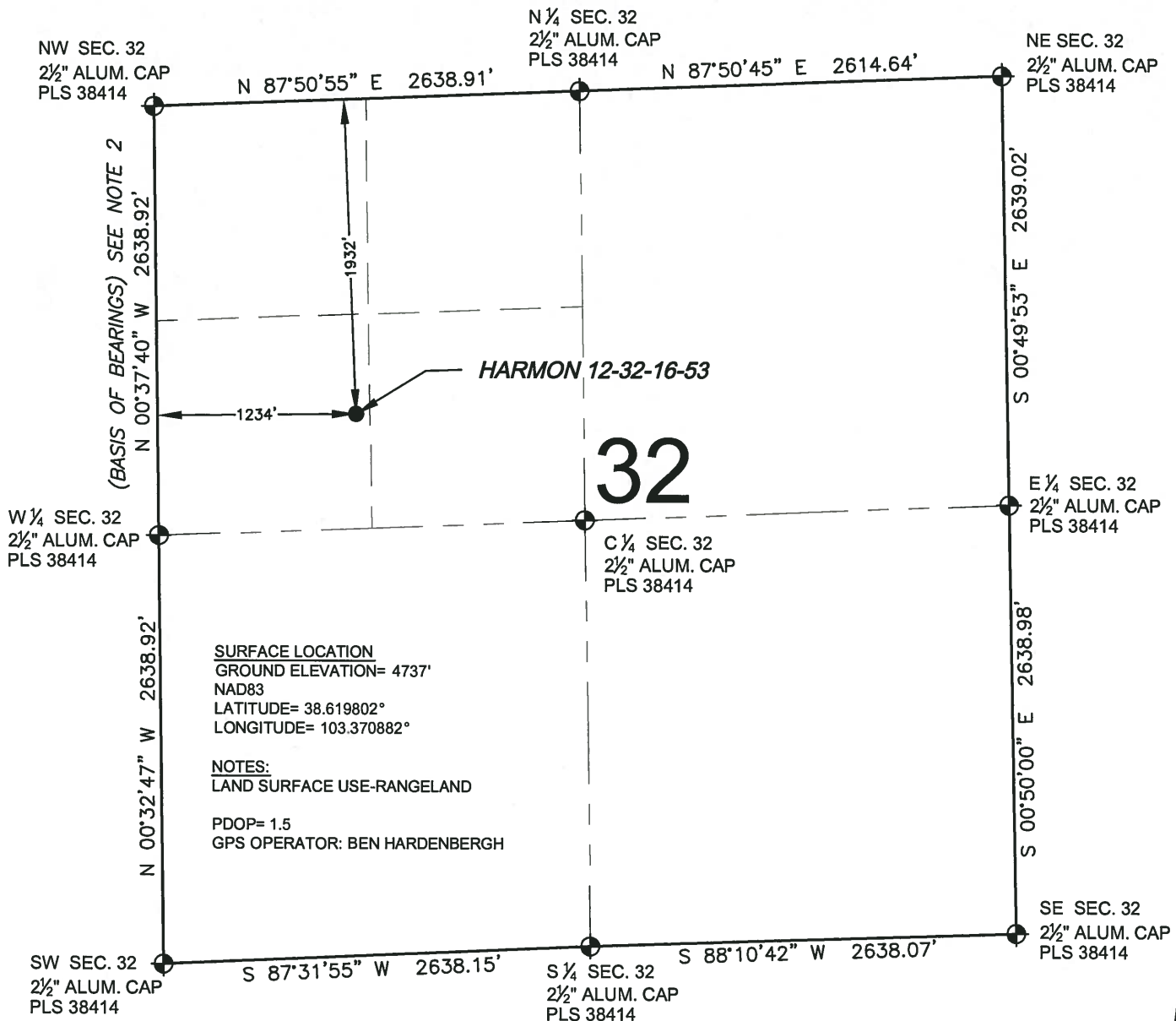


WELL LOCATION CERTIFICATE: HARMON 12-32-16-53

- ◆ = EXISTING WELL

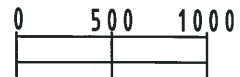
