Attached are the laboratory reports and the sample location map for the soil samples collected from the impacted area and nearby non-impacted native soil in order to close the produced water release incident that occurred at the GM 268-3 well pad location and was discovered on April 14, 2014.

- One grab sample was collected from the impacted area to verify if any excavation activities are required. The sample was analyzed for the constituents listed in Table 910-1.

- Three grab samples were collected from nearby non-impacted, native soil to establish the background concentrations for arsenic. In accordance with the COGCC Rule 910.b.(3)E. one grab sample was analyzed for inorganics to establish background soil conditions. As the attached lab reports indicate, all constituents of concern listed in the COGCC Table 910-1 tested below the cleanup requirements or below the background concentrations with the exception of the inorganics. Therefore, in accordance with COGCC guideline Q32 regarding inorganics, the GM 268-3 location and the access road will be covered with 3' of clean soil during final reclamation of the site in order to account for this exceedance.

Based on these results, WPX respectfully requests closure of this incident.
