COMMENTS:

This water re-use plan submittal is intended to allow Encana Oil & Gas (USA) Inc (COGCC 100185) to temporarily transfer produced water to Piceance Energy, LLC (COGCC 10433) for completion of 5 wells. Piceance has a need for up to 450,000 bbls of produced water for completion operations in Garfield County, CO. Piceance and Encana has reached and agreement to allow for the transfer of produced water from Encana's (GMR 67S-93WNWNE COGCC ID 334766 NWNE, Sec. 9, T7S R93W) (aka N9W) pad located in the Hunter Mesa Unit to Piceance Energy's temporary surface line. Encana's water valve on the N9W pad will serve as the Custody Transfer Point. The water will then be pumped to Piceance's Federal 31-01 pad (ID 335166 in the NENE of Sec. 31, T6S, R93W) and into an approved temporary lined pit. From the pit, the water will then be pumped through temporary surface line and continue on to Piceance's completion operations of 5 wells on the Federal 29-11 pad (ID 335515 in the NESW Sec. 29, T6S, R93W 6th PM Garfield County). Piceance will test and verify the compatibiliyt of the produced water provided by Encana. Transfer of the produced water will begin upon COGCC approval and terminate after one year with an option for extension.
