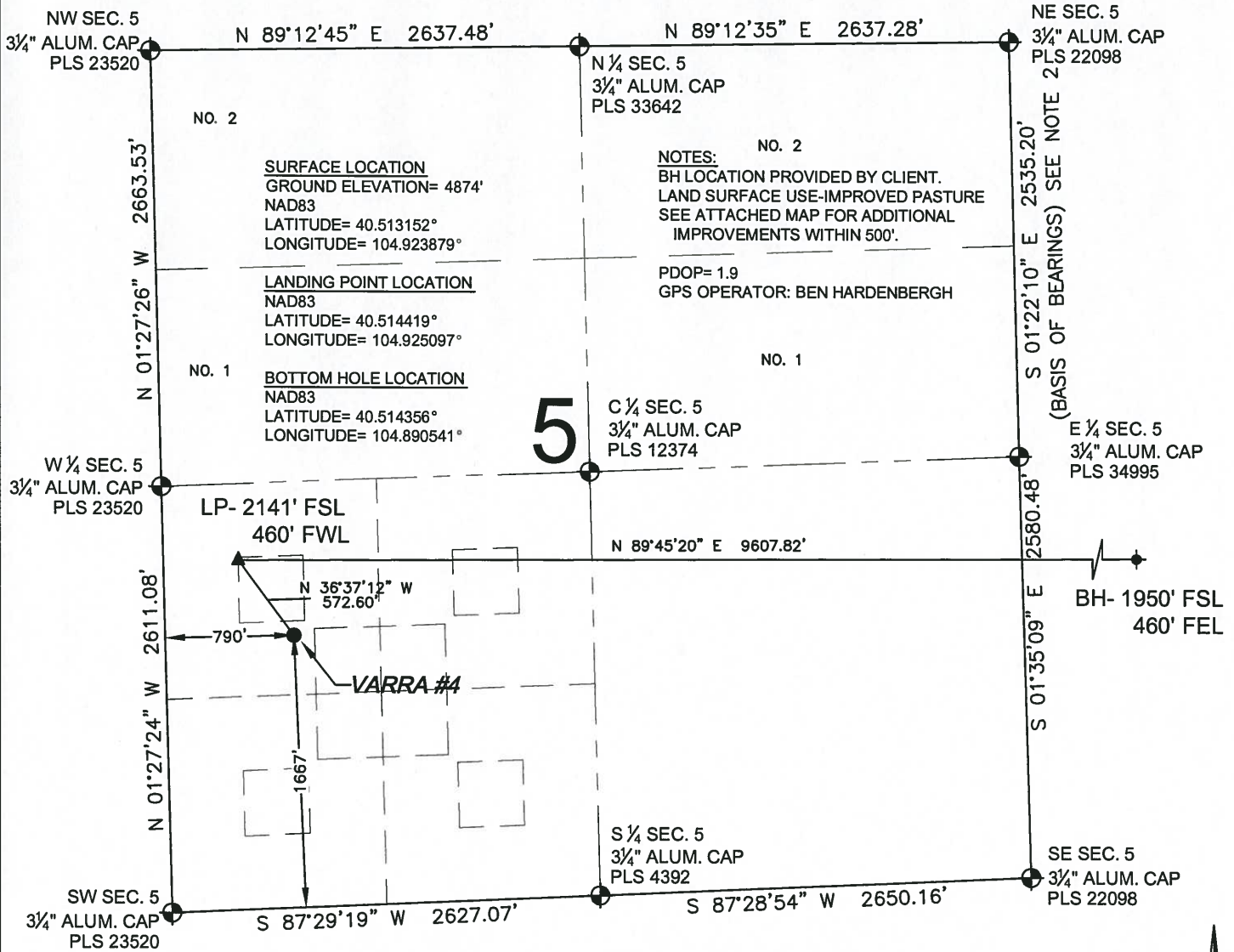
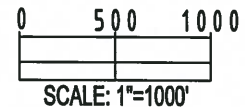


WELL LOCATION CERTIFICATE: VARRA #4

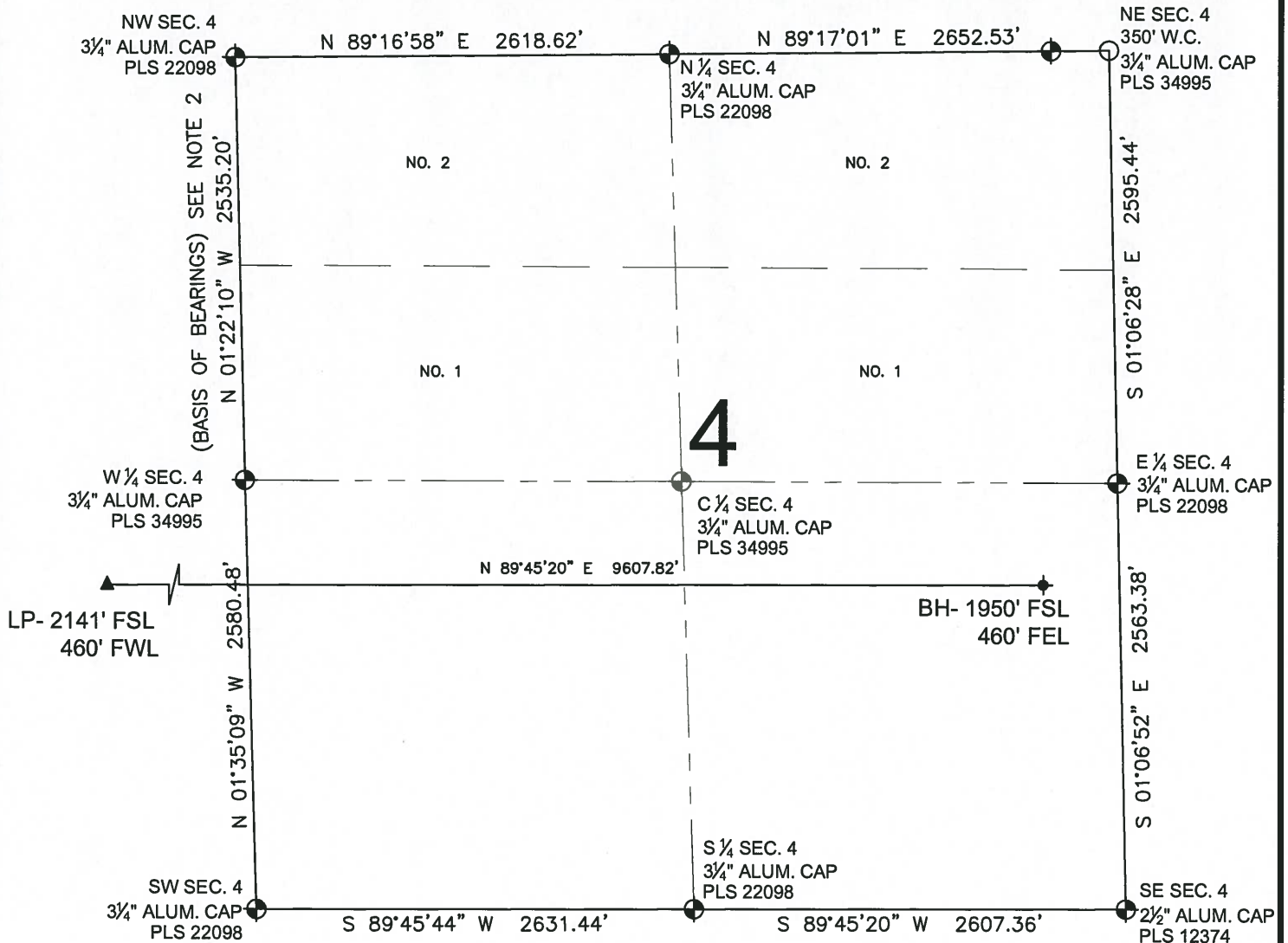
