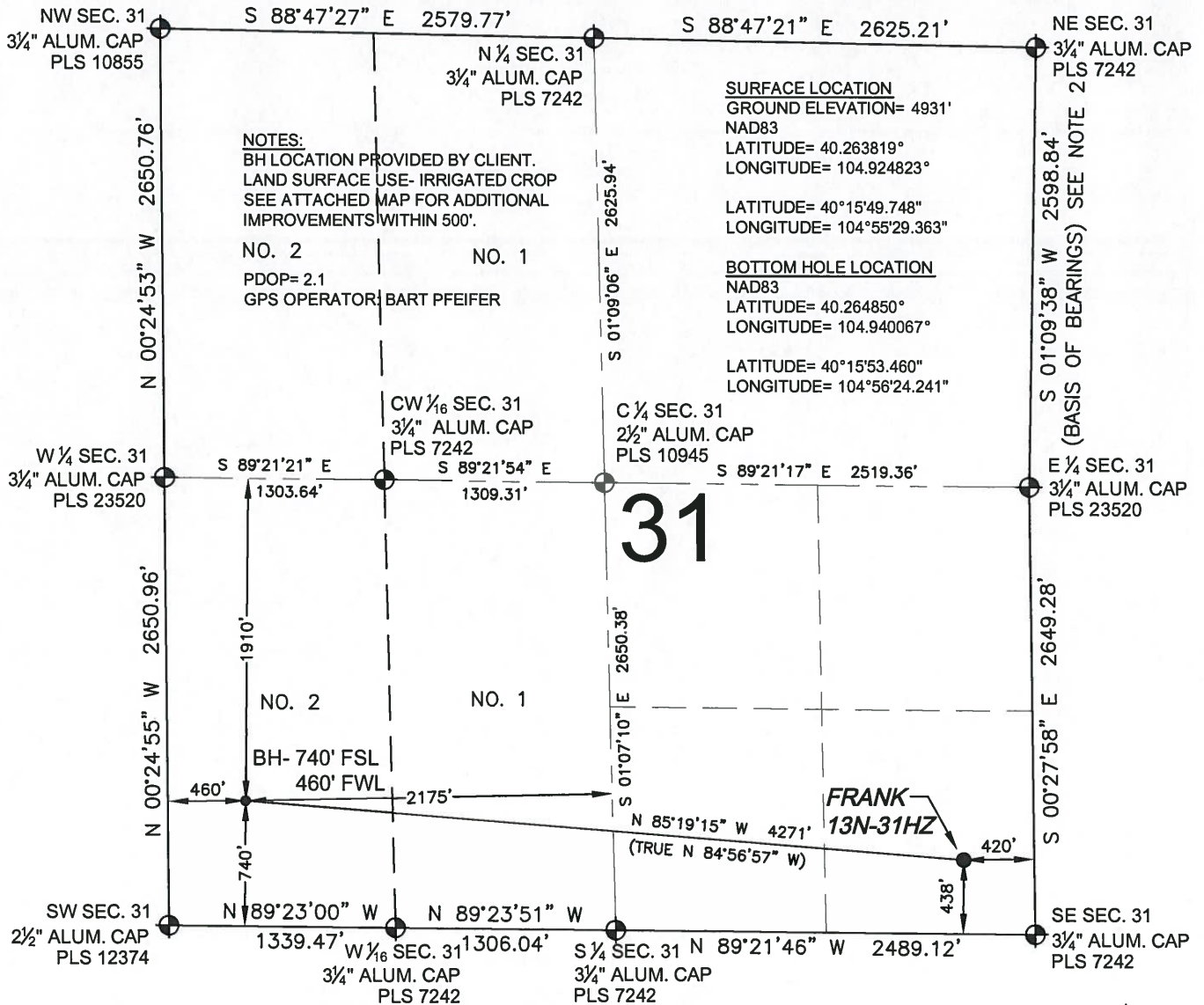


# WELL LOCATION CERTIFICATE: FRANK 13N-31HZ
