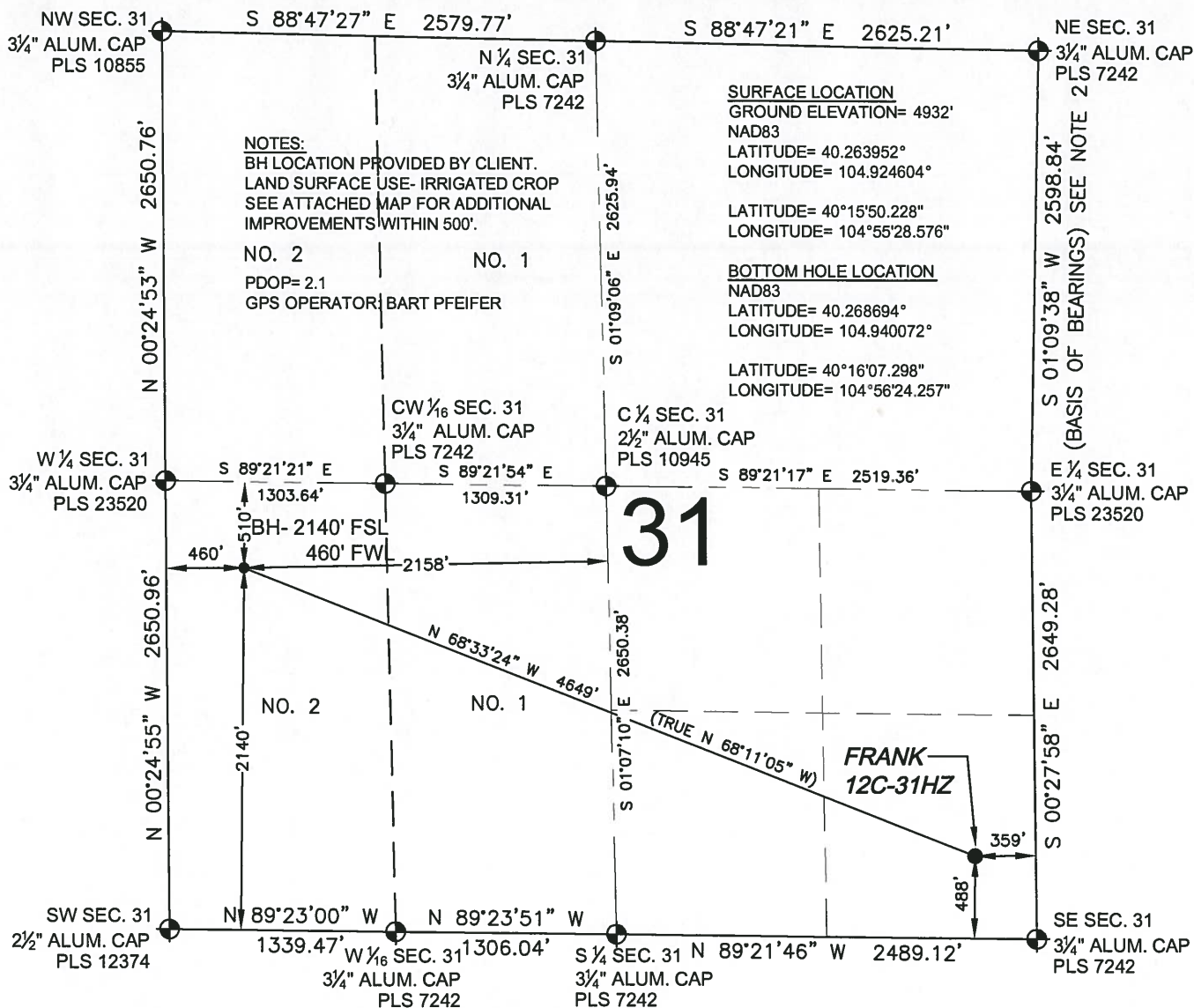


WELL LOCATION CERTIFICATE: FRANK 12C-31HZ

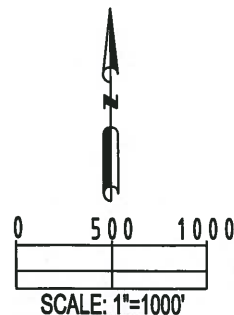
