This Form 4 is being submitted for approval to drill and install thirteen Barometrically Assisted Remediation Technology (BART) valves which will be utilized for passive in-situ vapor extraction of VOC's from vadose the zone soil and the hydrocarbon impacted groundwater. All valves will be advanced to a total depth of 25' bgs and 15' of screen will be installed beginning at 10 bgs to the total depth of 25' bgs. Attached is the proposed BART valves location map. The COGCC remediation number for this project is 5258.
