Paul,

I have review ed the Form 27 for Drilling Pit closure. The information provided is not sufficient to close the pit and outstanding NOAV, doc number 200315279 issued 6/24/2011.

COGCC rule 1003.d (2) Drilling pit closure on non-crop land, "Operators shall ensure that soils meet the concentration levels of Table 910-1".

The Soil Analysis provided, hand screening with a PID from surface to a depth of 3', does not satisfy **rule 1003.d(2)**. Soil samples shall be collected and submitted to an analytical lab for the complete Table 910-1 list of constituents.

Spud date was 11/15/2008, there was oil and trash witnessed in the pit in 2011, at that time Wellstar was advised to consult with COGCC environmental staff to ensure pit was closed per rules. This was not done.

The path forward to getting the pit and NOAV closed is; submit a form 27 work plan for sampling the area below the pit, in order to demonstrate soil complies with table 910-1, specifically characterizing the pit bottom. Once the work plan is approved sampling may commence. At that time a Form 27a can be submitted with sample results demonstrating that soil is below 910-1 standards and a request for no further action and closure of NOAV is possible. It is suggested that Welstar retain the services of an environmental professional or an environmental consulting firm.

Please be advised that all outstanding NOAV's are currently being reviewed by enforcement staff and will be going to hearing proceedings faster than they have in the past.
