

It appears that the pit was physically closed, I can not find any analytical or supporting documents on the pit closure. Facility id is 113021 and status is active. Attached is a pic from our database and you can see the pit south of well...

Mr. Sullins,

COGCC has received the Form 27 submitted for remediation activities completed at the above referenced facility. The form has been approved, and assigned Remediation #7539. Based on our review of this information, COGCC concurs that there is no apparent impact to soil and the Remediation Project number has been closed in the COGIS database (via Form 27 a document #1949163). However, it should be noted that this case could be re-opened in the future. Should conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards, or, if ground water is found to be significantly impacted, further investigation and/or remediation activities may be required at the site. Surface reclamation must meet the COGCC 1004 series rules for vegetative cover. A copy of the signature page indicating that the form is approved is attached; please retain a copy of this email as verification of No Further Action required.
