DUE TO THE SHALLOW GROUNDWATER (10 FEET BGS) AND THE HIGHLY PERMEABLE NATURE OF THE UNCONSOLIDATED MATERIALS (COARSE SAND AND GRAVEL), THE PROPOSED WELL PAD AREA HAS BEEN DESIGNATED A SENSITIVE AREA, THUS REQUIRING EITHER A CLOSED LOOP SYSTEM OR LINED DRILLING PIT.
