Dear Mr. Barber,

This letter is to advise you, as Surface Owner it is our intent to commence drilling operations for a natural gas well in the above referenced location. If you have a tenant leasing this location, please notify them of this operation. Should you and/or your tenant desire to be present during the staking process, please contact Loni Davis at the Wray office @ 970-332-3585. If you are not the Surface Owner of the Southwest of the Southeast quarter of Section 7, Township 5 North, Range 46 West, we ask that you please notify this office immediately so that the proper land owner may be notified.

We hope to commence drilling operations during the 3rd quarter (after crop) of 2014 calendar year. We will contact you prior to moving onto location as we learn the approval date of the APD, rig availability and title approval.

COGCC rule 305.f. requires a thirty-(30) day notice to landowners prior to commencement of drilling operations. Mr. Gary Timmer will contact you for a surface owner consultation per COGCC Rule 306.

Per COGCC rule 305.f.(3) we have enclosed a drawing of the proposed location to include placement of pipelines and facilities, the COGCC Informational Brochure for Surface Owner. COGCC Rule 305.c. gives you the right to submit written comments about the proposed location to the Director, the LGD and to Augustus Energy Resources LLC, as well as receiving the Form 2A, the major equipment list, a plat showing visible improvements within 500' of the location and a topo map showing the proposed access route and the COGCC hydraulic fracturing informational sheet. We will provide you with the information referenced above unless you waive your right to receive these documents.
