I am conducting a final review for Director's approval of the referenced Form 2A. The Drilling Waste Management had errors that required correction:

1. Although you indicated that **Fluids** disposal would be Offsite through an "Other" described method, the method described should be considered "Land Application" as a soil amendment at the listed Land Application Site (Facility ID 435839), based on the information contained in the waste management plan submitted for that site. I have changed the cuttings disposal method accordingly.
2. Although you indicated that **Cuttings** disposal would be Offsite through an "Other" described method, the method described should be considered "Beneficial Reuse" as a soil amendment at the listed Land Application Site (Facility ID 435839), based on the information contained in the waste management plan submitted for that site. I have changed the cuttings disposal method accordingly.
3. You have indicated that a beneficial reuse or land application plan has not been submitted. However, following a January 7, 2014 inspection of the Land Application Site (Facility ID 435839) by COGCC, Bayswater did submit the necessary documentation per Rule 907.a.(3). The waste management plan provided supports this information. Therefore the answer has been corrected to "YES".
4. As stated in your "Other Disposal Description," the Reuse Facility ID should be indicated as 435839. I have made the change.

As a result of confusion regarding the Fluids and Cuttings for this Oil and Gas Location, I am also adding the following condition of approval (COA) to this Form 2A: **"Notify COGCC via Form 42 prior to transporting Drilling Waste offsite."** This notice will be automatically provided to COGCC OGLA Specialist, who will notify COGCC regional Environmental Protection Specialist.
