Cascade is requesting that the COA requiring a pit liner due to shallow ground water be removed. Attached is a groundwater assessment from a nearby completed by LT Environmental in May, 2013 well showing shallow groundwater is not present in the area. The drilling pit was dug without encountering groundwater. The surface casing string has been pre-set to 500' and no groundwater flows or gravel beds were encountered.
