Dear Mr. Kelly,

Bonanza Creek Energy, Inc. ("Bonanza") has submitted applications to drill and produce the above referenced Niobrara Formation horizontal oil and gas wells, to be located as described above. This OGLA and APD package is a modification of the original State Seventy Holes F-6 pad which has been adjusted to meet the location requirements of the Colorado State Land Board and the COGCC.

Under Rule 305.c Completeness determination and comment period notifications; Bonanza is required to notify you that the above permit(s) have passed completeness and are in process for approval. During the approval process a 20 day public comment period has opened. The COGCC shall not approve a form 2A, or any associated form 2, for a proposed well or production facility for twenty days from posting pursuant to rule 305.b. You may view and comment on the permits online, using the COGCC website.

Rule 305.c(5) allows operators to obtain an expedited approval and waive the 20 day comment period, with a signed waiver from the landowner and LGD. Due to extenuating circumstances Bonanza respectfully requests that you review the enclosed information and sign the waiver for Rule 305.c, 20 day public comment period.

Upon receiving the 20 day comment period waiver and expedited approval of a form 2A and 2 (APDs);

Bonanza Creek intends to spud on or before July 29, 2014.

If not granted expedited approval Bonanza will face significant economic hardship. In addition to the economic results, delayed approvals will result in increased truck trips and traffic, hindering our BMP (Best Management Practice) efforts to mitigate the impact of our operations.

A form is enclosed which provides you the opportunity to waive the rule 305.c 20 day public comment period.
