Noble Energy, Inc. respectfully requests permission to vent/flare the gas produced at the Bashor AC18-62HN location for a period of six (6) months at a vented/flared gas volume of 110MCF/day. There is a current CDPHE in place for the vent/flare of the gas. This document is included in this application.

Noble is currently in negotiations for the ROW's to build a pipeline. This request length of six months is to accomodate the negotiations, construction and hook-up of the pipeline to transport the gas to the sales point.
