COMMENTS:

Pressure was seen on the Braden head surface casing after frac job. 240 psi of pressure was initially seen on 3-31-14. Pressure was released daily and is currently at 40 psi. Bayswater will continue to bleed off pressure daily for 30 days. At that time the Braden head surface casing will be shut in for 7 days, then the pressure will be monitored. If the pressure builds in the 7 day time another 30 days of pressure release, followed by 7 day shut in. This will be repeated for 3 cycles if necessary. If pressure is seen after third cycle Bayswater will complete an annular fill operation per the states recommendation.
