Run and submit CBL to verify cemented intervals. 3) If well is a dry hole set plugs at the following depths: 40 sks cement +/- 50' above the Osage, 40 sks cement +/- 50' above the Cherokee, 40 sks cement +/- 50' above any DST w/ show, 40 sks cement at 4850' up, 40 sks cement at 4150' up, 50 sks cement from 50' below surface casing shoe up into surface casing, 15 sks cement in top of surface casing, cut 4 ft below GL, weld on plate, 5 sks cement each in rat hole and mouse hole.
