COGCC has assigned spill tracking #400639217 to this release. I inspected the location yesterday afternoon. Additional excavation was required to remove impact soil above the ground water. Ground water has been impacted and will require post-excavation monitoring, at a minimum. However, since the source has been controlled and is being removed, I don't think the impacted ground water will extend very far beyond the tank battery footprint, but Bonanza Creek will submit an assessment report with analytical data for COGCC review.

Ken,

Bonanza Creek has confirmed this release to COGCC. They have informed me that all pooled fluids have been removed and excavation will begin early next week. Bonanza Creek will be required to submit documentation for the extent of impact and for the removal of impact, including soil sample analytical results. If ground water impacts are discovered, Bonanza Creek will be required to submit a remediation plan to address those impacts.

As soon as we assign a spill tracking number for this release, I can point you to that information.
