


Access Road Map



SECTION 15, T1S, R100W, 6th P.M.

PROCEED IN AN EASTERLY THENCE NORTHERLY THENCE EASTERLY DIRECTION FROM RANGELY, COLORADO ALONG STATE HIGHWAY 64 APPROXIMATELY 10.5 MILES TO THE JUNCTION OF STATE HIGHWAY 64 AND COUNTY ROAD 122 TO THE SOUTH; TURN RIGHT ONTO COUNTY ROAD 122 AND PROCEED IN A SOUTHERLY THENCE SOUTHEASTERLY DIRECTION APPROXIMATELY 14.0 MILES TO THE JUNCTION OF COUNTY ROAD 122 AND COUNTY ROAD 103 TO THE SOUTHEAST; TURN RIGHT ONTO COUNTY ROAD 103 AND PROCEED IN A SOUTHEASTERLY THENCE SOUTHWESTERLY DIRECTION APPROXIMATELY 6.6 MILES TO THE BEGINNING OF THE PROPOSED ACCESS FOR THE CBU O15 1100 (PHASE I) WELL PAD TO THE SOUTH; TURN LEFT AND FOLLOW THE PROPOSED ROAD STAKES IN A SOUTHERLY DIRECTION APPROXIMATELY 503' TO THE PROPOSED CBU O15 1100 (PHASE I) WELL PAD.

TOTAL DISTANCE FROM RANGELY, COLORADO TO THE PROPOSED CBU O15 1100 (PHASE I) WELL PAD IS APPROXIMATELY 31.2 MILES.
