#### COMMENTS:

Elm Ridge Exploration Co LLC spud this well on 7-7-14. We drilled a 12 1/4" hole to 550'. Set 8 5/8" 24# J55 casing at 542'. We used 370 sks of cement with 20 bbls of good cement to surface. We reached a TD of 3897' on 7-13-14. We ran 5 1/2" 17# J55 casing to 3887'. We used 320 sks of cement tailed by 260 sks of cement. We had 62 bbls of good cement to surface.
