Elm Ridge spud this well on 7-15-14. We drilled a 12 1/4" hole to 548'. We set 8 5/8" casing at 531'. We used 370 sks of cement and had 32 bbls of good cement to surface. We reached a TD of 3362' on 7-20-14. WE used 285 sks of lead cement and tailed in with 230 sks of cement with 16 bbls of good cement to surface.
