Ursa Operating Company, LLC would like to receive water for completions operations. If permitted to do so, water will be collected from temporary tanks via Encana's (TWIN CREEK-67S92W1SWSE COGCC ID 334939 SWSE, Sec. 01 T7S-R92W) (O1E) pad located inside the Hunter Mesa Unit (Unit ID: COC55972X). Ursa will collect water via temporary water tanks. Once water leaves Encana's temporary tanks (TWIN CREEK-67S92W 1SWSE COGCC ID 334939 SWSE, Sec. 01 T7S-R92W) this will serve as Point of Custody. Ursa plans to take water from the Point of Custody to use it for completions operations on their (Castle Springs Federal E Pad COGCC ID 418828 NESW Sec. 09 T1S-R91W) pad. All wells are located in Garfield County, Colorado. Ursa Operating Company, LLC will test and verify compatibility of the produced water provided by Encana. Transfer of produced water would begin upon COGCC approval and terminate after one year with an option for extension.
