This is an informational sundry. Earlier this year, the horizontal wells on this location were hit by an offset frac and this resulted in lost production in a few of the wells. Encana is planning on installing a temporary hydraulic jet pumping system on this location to recover production. The temporary equipment to be installed will include an inlet sand trap, an inlet separator, and a jet pump skid. The equipment will only be on location for as long as the frac recovery takes, which could range from 2 weeks to 3 months. Once the wells start producing again, all the equipment will be removed.
