#### COMMENTS:

Operations to abandon the conductor for this undrilled well were completed on 6/3/14 by Whiting Oil & Gas Corporation.

Details: 16" Conductor pipe was filled with 24 sxs cement (3.9 bbls) from tagged depth of 17', cut 5' below ground level, and an ID plate was welded on top. Location was backfilled. COGCC was notified, but not on location.

As noted on the notice of intent sundry, the pad will not be reclaimed at this time as Whiting owns the surface.
