Rig-up, install & test BOPs. Rig up slick line, set plug in BR Profile located at ~8900', release pressure and test for isolation  
? Release injection tubing from on-off tool and pull tubing  
? Run gauge ring then set RBP at ~8400', dump 10' sand on plug  
? TIH with packer, testing casing for potential integrity issue  
o Isolate casing issue, obtaining a pump-in rate and pressure
