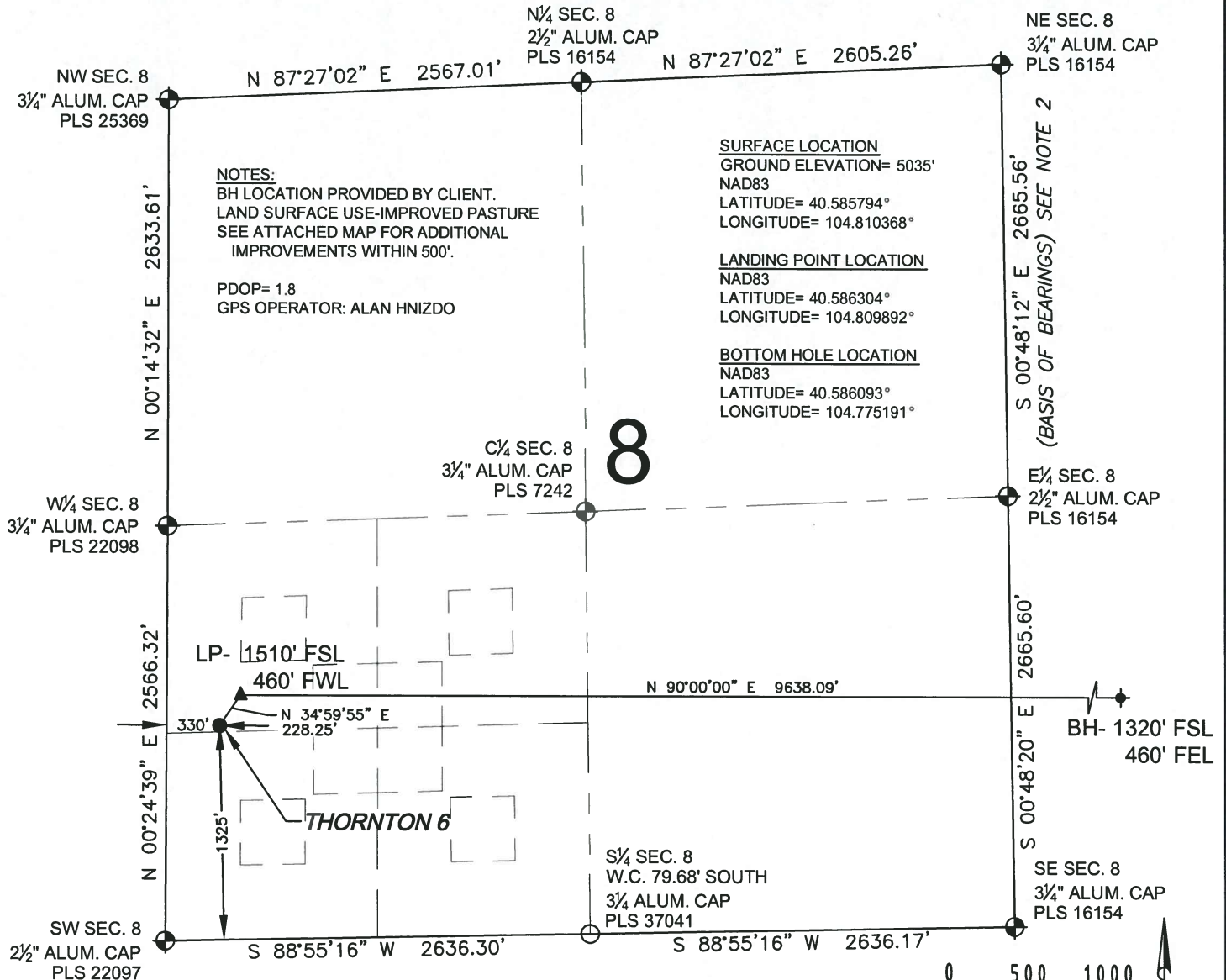


# WELL LOCATION CERTIFICATE: THORNTON 6

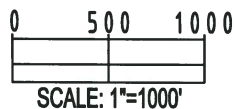

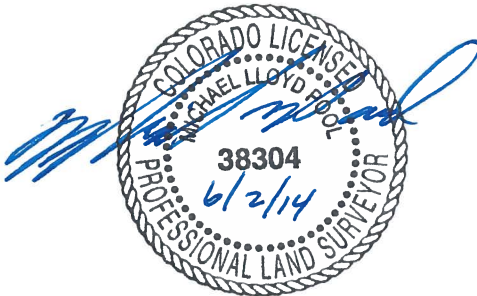
