Dear Mr. Clark,

Research of the COGCC website records discovered four of the referenced wells with Abandoned Location (AL) status have approved Form 4 location abandonments signed by previous COGCC Director Dave Neslin in 2009. The one well above with no Form 4 on record will require a Form 4 from Par to officially abandon the permit. As these are expired or abandoned permits and were never drilled, and are on existing producing locating no further action should be required.

Regarding the two wells that were "plugged and abandoned" or "drilled and abandoned", both of these wells are on active producing locations and no final reclamation of the sites will commence until the last well producing well on the location is plugged and abandoned. Once all wells are plugged, Piceance Energy or its successor will reclaim the well pads in compliance to COGCC rules. In the interim, the plugged wells will remain as they are.
