



WELL LOCATION CERTIFICATE



Lat40, Inc. has determined the surface location of the MOSS 7-19-7-44 to be 2033' from the NORTH line and 1993' from the EAST line as measured at right angles from the section lines of Section 19, Township 7 North, Range 44 West of the Sixth Principal Meridian, County of Phillips, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 7/18/2014, for and on behalf of Qmimex Petroleum, Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
