There is an indicated surface water area approximately 585' northeast of the proposed well stake and in the wheat stubbel. A barbed wire fence located 620' to the north and 853' to the east of well pad. The nearest water well is shown to be 1973' south of this location and according to the surface owner this well has never been used. The condition of the well prevents any sampling. A non-occupied structure, grain bins lies 5414' to the southwest of this location. County roads with overhead power lines lie south and west of this location. None of the above will be disturbed by drilling operations.
