#### COMMENTS:

A complete gas sample analysis is attached.

Gas was flared for 9 days during a 30-day period beginning June 3, 2014. The average flaring volume during this period was 102.2 MCF/D; volumes were measured daily. A pipeline connection was established on June 18, 2014, and gas has been flowing to sales. Frequency of flaring will decrease as the flowback and maintenance phase of the well is completed.

There is a presence of H2S; sampling showed 2ppm.
