Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the Sec 1: W/2E/2, Sec 12: NW/4NE/4, T6N, R63W, creating a 200-acre wellbore spacing unit for the Niobrara formation. Thank you for your attention to the enclosed. NEI respectfully requests that the COGCC review the enclosed information and approve the Application for Permit to Drill the captioned well.

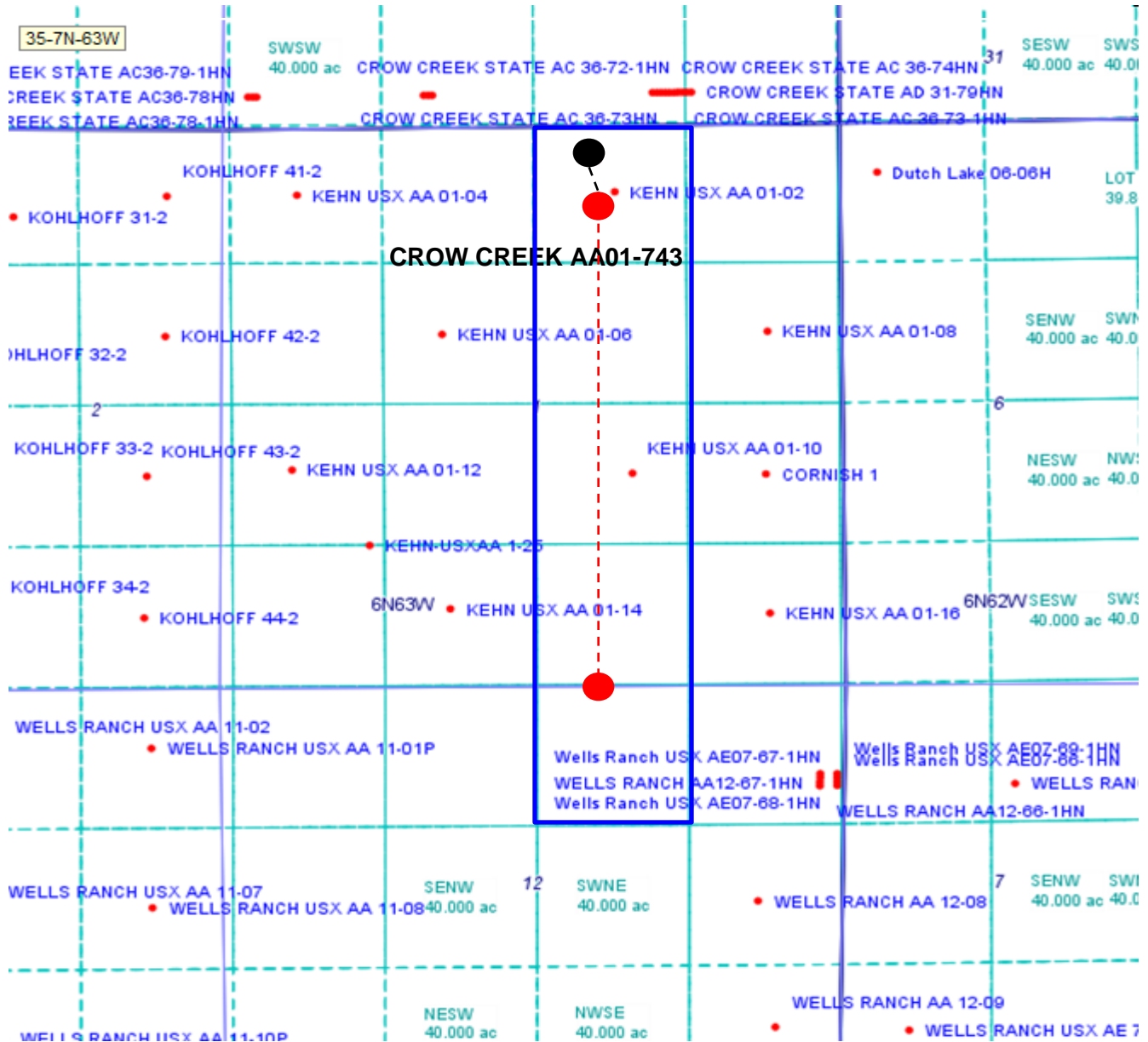

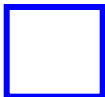

Bottom Hole Location

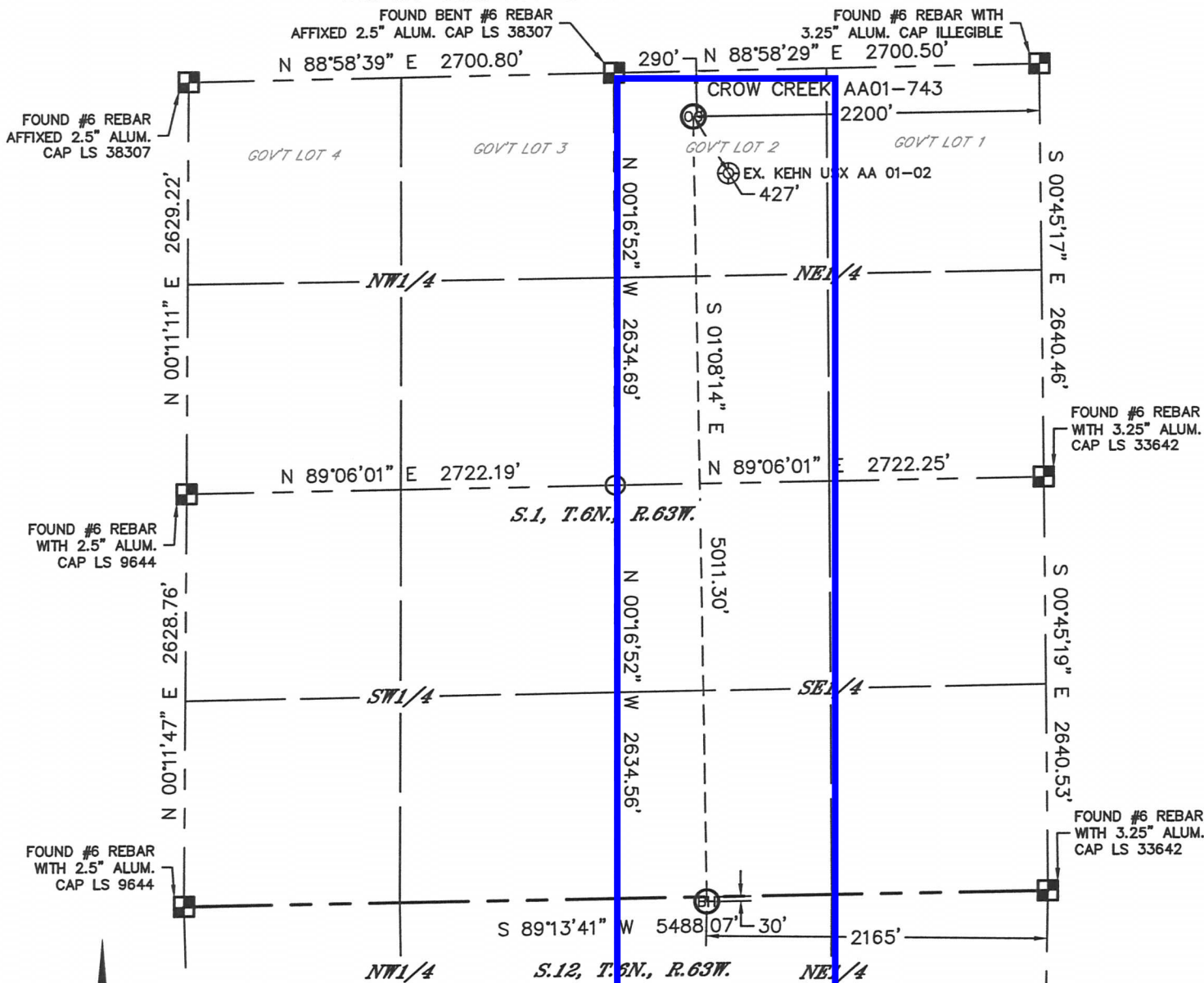
