## COMMENTS:

The purpose of this Form 4 is to receive COGCC's approval to excavate hydrocarbon impacted soil in the area adjacent to the MW-1 located at the PA 311-4 production facility. See attached map. Remediation project # 4251. Eleven rounds of quarterly sampling have been completed since November of 2011. The benzene concentrations are slightly elevated, above the COGCC standards, in MW1 (see previously submitted sampling reports). In September of 2011, DeepEarth Technologies treated the area adjacent to MW1 by injecting ~5400 gallons of the Cool-Ox reagent; see attached map. On July 21, 2014, the treated area was sampled, at depth of 4-5', to verify if the hydrocarbon levels are below the COGCC 910-1 requirements. The analytical results indicated that the hydrocarbon concentrations in PH 9, are slightly above the COGCC standards (analytical data is attached). Therefore, WPX proposes to excavate approximately 400 yards of soil from the area near MW1 to a depth of 6' below the pad level in order to remediate the remaining hydrocarbon impacted soil. Once the excavation activities are completed, the MW1 will be reestablished. The excavated area will be backfilled with clean material. The excavated material will be treated for hydrocarbons at the PA 41-5 well pad (COGCC location # 334626). The MW1 will continue to be sampled on a quarterly basis.
