Paul,

This significantly changes this location and the information required on the Form 2A. The Facilities, Construction, Cultural Distance, & Water Resources sections would need to be updated. Also, the Location Drawing, Reference Area Map, Access Road Map, and Hydrology Map would need to be revised. They would no longer accurately show the extent of the location, the 500' Improvement Buffer for the Location Drawing would be incorrect, the 1,000' buffer for the Hydrology Map would be incorrect, and the Reference Area would now fall within the disturbed area as shown on the included Facility Layout Drawing.

I have neither the time no desire to change this information and swap out all of these required attachments. Therefore, I think there are two ways we can handle this. Either Withdraw this 2A and you correct all these items to include the larger disturbance area and resubmit the Form 2A. Or, leave this 2A as it was submitted and submit an Amended 2A in the very near future to add the Tank Facility area to this location. Please let me know how you would like me to proceed.

Unfortunately, once a 2A is IN PROCESS it cannot be sent back to DRAFT. It can either be WITHDRAWN or we will have to review and process it as submitted. Can you tell me about the existing facility just to the north of and adjacent to this location?

Also, because this area is within the Upper Crow Creek Designated Groundwater Basin, it is be definition considered a Sensitive Area. So I changed that part of the Water Resources section from NO to YES.
