- 3 RIH and set plug at 7700'. POOH.

- 5 Run CBL from plug to surface.
- 6 If cement is not detected over the interval from base of surface casing to +/-1900', proceed with annular cement job as follows:

 - b. TI annulus with 1-1/4" tbg to +/- 1900'
 - c. Mix and pump cement sufficient to cover from 1900' to 250'.
 - d. TO annulus, ND flange, reland casing.
 - e. WO cement .
 - f. Run CBL from 2000' to surface to verify coverage.
- 7 Replace wellhead and valves to ensure 5000 psi rating.
- 8 TI hole to retrieve plug.
