Methods used for interim reclamation of the Murphy Family 4-64-25-1H include contouring of the location to blend with surrounding landscape, spreading of top soil over contoured areas at a depth of 6 inches, establishing drainages to allow run off to be captured in silt traps, or catch basins. Waddles were utilized to prevent erosion until growth has been established. Re-seeded the entire contoured areas with customary seed mix.
