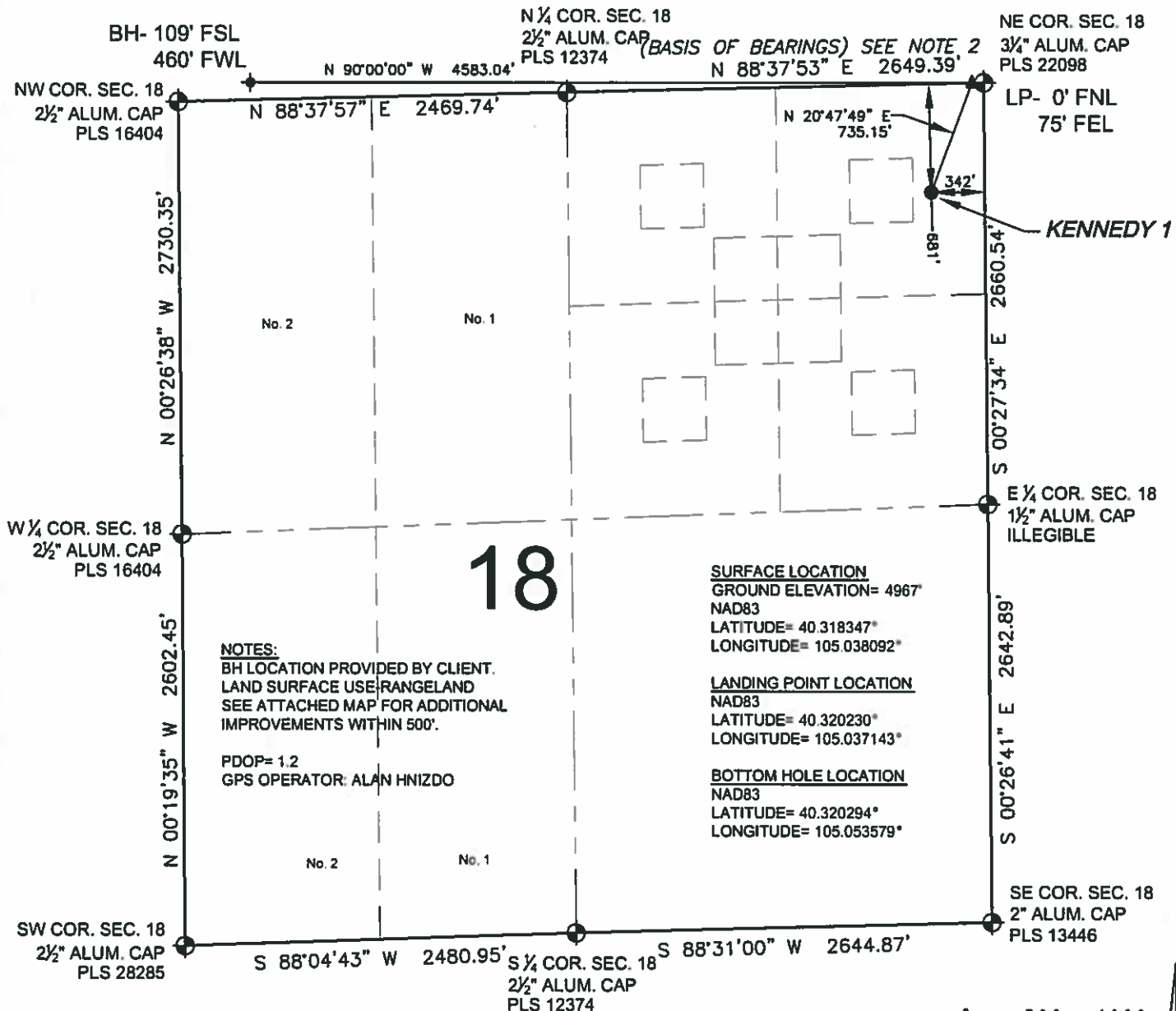


WELL LOCATION CERTIFICATE: KENNEDY 1

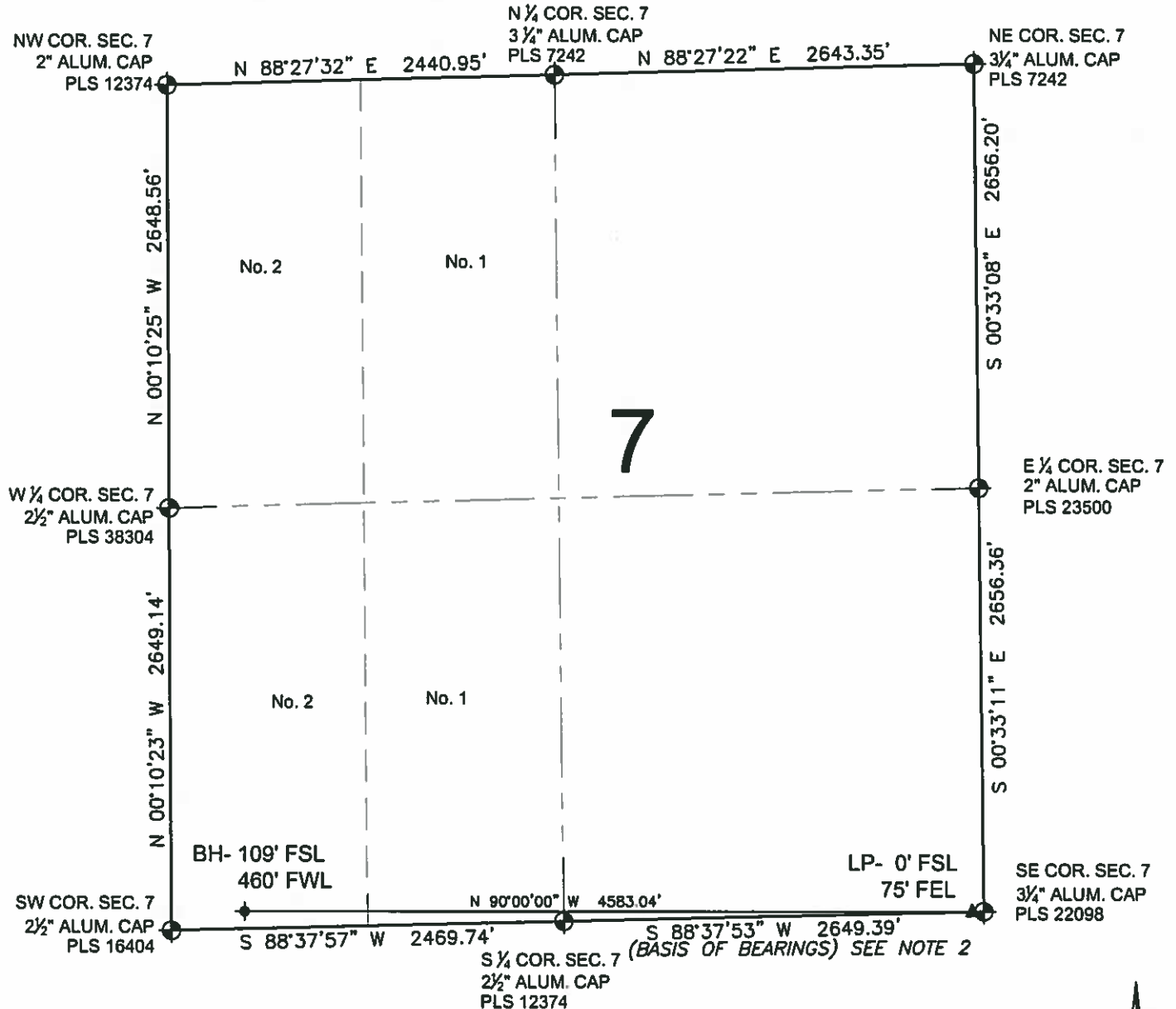

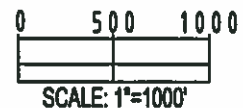
