COMMENTS:

High bradenhead pressure was recorded on 7/7/14 while resuming the stage 3 of frac operations after being SI for the 4th of July. The bradenhead pressure is being monitored and recorded daily and are currently consistent at 150 psi.

Once all wells on the pad are completed and the frac crew has cleared the location we propose to conduct a 30 day blow down of this well to release trapped gas and follow up with a bradenhead test. Please see attached.
