COMMENTS:

We repaired the casing, had a leaking casing patch, so made the decision to perform an annular fill on the casing. We cemented from 200' below the casing patch (patch @ 1,690/ circulated from 1.900'). We had two intervals of good bond with a new TOC @ 720'. The casing was tested to 1,000 psi and held, the well will be returned to production.
