Jacob,

The 3 water wells noted on the Form 19 were determined using COGIS. I went to confirm those wells, but the GIS map is not working this morning. I used the Division of Water Resources Aquamap to determine how many wells they had within 1/2 mile, and these are the wells I found:

Permit #30523 - Domestic well approx. 1,374 feet west of site
Permit #118815 - Domestic well approx. 1,385 feet west of site
Permit #75772 - Domestic well approx. 2,243 feet west of site
Permit # 5846R - Irrigation well approx. 1,898 feet SW of site

All other wells within 1/2 mile of the site are monitoring wells. Not sure if that is what Rick is referring to.

Please let me know if you or he needs any more clarification or has any more questions.
