COMMENTS:

WPX Energy requests approval to use the GM 251-2 pad as a remote frac pad in order to re-complete the GR 31-2 well which is on the GR 31-2 pad. Three (3)-4.5" temporary surface steel frac lines will be laid in the bar ditch along the road from the GM 251-2 pad to the GR 31-2 pad. Attached is an overall location map showing the two pads as well as a zoomed in map showing the GM 251-2 frac pad and the berm that will be needed. 20 tanks for storing frac water during the recompletions operations will be set within this berm. No new disturbance will be needed on the GM 251-2 pad. Re-completions operations will begin upon approval of this sundry and other necessary permits and is expected to be finished in 2 weeks.

The surface frac lines will be pressure tested in accordance with Rule 1101.e.(1) prior to putting into initial service. The lines will be routinely inspected for the entire length of the line to ensure integrity.
