Alicia #12-15H-2N Well: 588' FSL, 1886' FEL Sec. 12-T1S-R68W, Adams County, Colorado

Dear Working Interest Owner,

Mendell Finsterre II, LLC (MFII), intends to propose, drill and operate the above referenced North-South trending horizontal well pursuant to Rule 318A.a.(4)D of the Colorado Oil and Gas Conservation Commission (COGCC). MFII will propose the well as follows:

1. **Surface and Bottom Hole Locations:**  
SHL: 588' FSL, 1886' FWL, Sec. 12-T1S-R68W  
Top of Producing Zone Location: 460' FSL, 1859' FEL, Sec. 12-T1S-R68W  
BHL: 833' FSL, 1863' FEL, Sec. 1-T1S-R68W
2. **Wellbore Spacing Unit:**  
The spacing unit for the subject well will consist of the 200-acres comprising the W/2 E/2 of Sec 12-T1S-R68W & SW/4 SE/4 Sec 1-T1S-R68W. The well spacing unit is depicted on the enclosed spacing unit exhibit.
3. **Target Formations and Geologic Statement:**  
This well is planned as a Niobrara horizontal, and the well will be drilled to a sufficient depth and reach in order to test the viability of said formation.
4. **Anticipated Spud Date & Surface Use:**  
Operation to begin within 60-90 days, pending receipt of required permits, approval of title, and drilling rig availability.

Pursuant to COGCC Rule 318A.e.(6), you have thirty (30) days from receipt of this notice to object to this proposal in writing. In the event you do not respond to this notice or enter an objection within the established time period, the proposed 200 acre spacing unit set forth herein shall be established. However, should you have no objection to this proposal; your cooperation of a written reply would be greatly appreciated in the form of this 30-day waiver. The waiver may be mailed to:
