Bonanza Creek Energy, Inc. ("Bonanza") intends to drill the above referenced horizontal oil and gas wells to the Niobrara or Codell Formations, from a well pad to be located as described above. The referenced planned wells and Production Facilities are located within the Buffer Zone Setback (500'-1000') of several building units.
