



In accordance with a request from Derek Petrie with NGL WATER SOLUTIONS DJ Lat40°, Inc. has determined the surface location of the C-1-C to be 336' from the SOUTH line and 211' from the EAST line as measured at right angles from the section lines of Section 8, Township 4 North, Range 64 West and the bottom hole to be 2161' from the NORTH line and 75' from the EAST line as measured at right angles from the section lines of Section 17, Township 4 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 7/18/2014, for and on behalf of NGL WATER SOLUTIONS DJ. 
