Access request letters were sent to landowners with potential water sources within the 1/2 mile radius of the location GM 323-28 (Facility ID 335318). Initially, access was granted for only two sources (Facilities 752711 and 752722), which were sampled in July and August of 2013 (samples 534753 and 534755). Surface casing was not set within a year of the sampling; new samples were rescheduled to meet the requirements of Rule 609 Pre-Drill sampling. During that time, access was granted to sample a third source (Facility ID 753285). The fourth source was not sampled because the landowner was unaware of any functioning wells in that location.
