Prior to completion operations the above well has been determined to present conditions needing further review and possible action. Please allow Kerr-McGee Oil & Gas Onshore LP to vent bradenhead valve on the subject well to an enclosed tank for 30 days in order to test and determine if remediation to the wellbore will be necessary. The bradenhead will be vented for 30 days, then shut-in for 7 days and a new Bradenhead test performed. This procedure may be repeated up to three cycles. At the conclusion of the cycles, if the pressure has not satisfactorily decreased a remediation plan will be proposed.
