#### COMMENTS:

Bradenhead Squeeze:

- 1) MIRU equipment, pumps, tanks, etc.
  - 2) POOH w/ 2 3/8" tubing.
  - 3) RIH w/ RBP. Set RBP at 50' above Codell (7178'). Spot sand on RBP. Load hole.
  - 4) RU WL. RIH w/ perf gun. Shoot squeeze holes 4750' and 4550'.
  - 5) RIH with packer on WS. Set packer at 4700'. Attempt to establish injection through squeeze holes with water. POOH with packer.
  - 6) RIH with CR on WS. Set CR at 4700'. Establish injection through squeeze holes with water.
  - 7) Pump 50 sx class 15.8 ppg cement, displace with 17 bbls water. Sting out of CR, pull up to 4500' and reverse out.
  - 8) Bleed off bradenhead pressure and monitor.
- If bradenhead pressure is not eliminated, re-squeeze and re-test. Contact office for further instructions.
- 9) RIH w/ 3 7/8" bit and drill out cement until fall out. Circulate clean. TOOH w/ 3 7/8" bit.
  - 10) RU WL. RIH w/ CBL tool. Run full CBL log. POOH w/ CBL tool.
  - 11) RIH w/ retrieving head. Wash sand off, retrieve RBP. POOH
  - 12) Test in 2 3/8" tubing. Land tubing at 7191' unless production foreman specifies otherwise.
  - 13) Clean up location. RDMO. RWTP.
